This Certification Letter pertains to TST's **Game Payout Calculation** for the live game play log files gathered from the VistaBet Casino ([www.vistabet.com](http://www.vistabet.com)) Internet Gaming System (IGS), as supplied by Boss Media to TST, for the period of 01 October 2010 to 31 December 2010.

TST's **Game Payout Calculation** of the average payout percentages (i.e.: the percentage of wagers that are paid back to the players in the form of winnings) have resulted in the following values for the live game play log files submitted by Boss Media:

TST's **Game Payout Calculation** was limited to analysis in our laboratory environment, and was based solely on the live game play log files submitted by Boss Media on 19 January 2011. For verification purposes, TST has maintained a control version of these live game play log files. The scope of work for TST's **Game Payout Calculations** did not include a technical assessment of the VistaBet Casino ([www.vistabet.com](http://www.vistabet.com)) IGS or the associated Information Systems (IS) and financial controls.
